- *Minimum 25 years of service*
 - *Actively employed on or after January 1, 2003*
 - *Is not awarded posthumously*
- George Beaulac Memorial Award – Deadline April 1, 2012**
- *Minimum 10 years involvement with EMS service as owner, operator or RHA representative*
 - *Recognizing ongoing support of SEMSA and work done with the provincial association to strengthen the community of EMS*
 - *A builder of the EMS community*
- SEMSA Scholarship – Deadline April 1, 2012**
- *One \$1,000.00 scholarship awarded yearly to further professional development*
 - *Training must be advancement in the EMS field i.e. PCP to ACP or degree*
 - **Must** submit this form **together** with two letters of reference
 - **Must** submit 500 words or less essay why you are deserving and hope to accomplish
 - **Must** submit transcript, certificate and/or proof of current registration in program
 - **Must** have taken further training within Saskatchewan and be currently employed in Saskatchewan
- Memorial Scholarship – Deadline April 1, 2012**
- *One \$1,500.00 scholarship awarded yearly to further advance as an advance care provider*
 - **Must** be presently a licensed practitioner in Saskatchewan registered or having completed within past 1 year an ICP or ACP training program
 - **Must** submit this form **together** with one letter of reference
 - **Must** submit 500 words or less essay why you are deserving and hope to accomplish with higher level of training
 - **Must** submit transcript, certificate and/or proof of current registration in program
 - **Must** have taken further training within Saskatchewan and be currently employed in Saskatchewan

- *Presented annually during EMS week by the Lieutenant Governor*

Governor General EMS Exemplary Service Medal

- *Minimum 20 years of service, 10 years of which are in direct patient care*
- *Canada’s Highest EMS honor*
- *Will receive additional recognition for every 10 years of dedicated service*
- *Actively employed on or after October 31, 1991*
- *Can be awarded posthumously*
- *Names selected by a provincial committee then submitted to a national body for verification before final selection is made*

Saskatchewan Protective Services Medal

- *Minimum 25 years of service*
- *Actively employed on or after January 1, 2003*
- *Awarded by the Government of Saskatchewan at a provincial recognition ceremony during the year*
- *Is not awarded posthumously*

George Beaulac Memorial Award

- *Minimum 10 years involvement with EMS service as owner, operator or RHA representative*
- *Recognizing ongoing support of SEMSA and work done with the provincial association to strengthen the community of EMS*
- *George Beaulac was a tireless advocate for EMS in this province both provincially and nationally. His dedication installed a true community spirit that foster goodwill and friendship amongst all. He was an advocate for the association and a stronger provincial builder. This award seeks to find individuals to emulate these qualities.*
