### Position Overview:

---

Rosthern Ambulance is an Advanced Life Support service that responds to approximately 600 calls annually. We are seeking full time staff at the ACP level to provide regular and on call services. Rosthern Ambulance has recently moved to a 5-5-4 rotation with M-F day shift (0800-1800) and nights and weekends on call. Rosthern Ambulance will offer casual shifts to ACP's and/ or PCP's in the interim until this position is filled. Rosthern is situated in close proximity to Saskatoon and prides itself on the quality of life that it affords. Sports, Arts and Culture as well as the outdoors are all prominent features of the lifestyle you will find in this community.

Under the direction and supervision of the Operations/Training Manager, the Emergency Medical Technician - Paramedic is responsible for providing emergent and non-emergent Advanced Life Support (ALS) services to the sick and injured. And for continuing to provide ALS medical services until responsibility for patient care can be assumed by Hospital authorities or another designated Advanced Life Support (ALS) provider.

### Accountabilities:

---

- Respond to emergency situations, as required, in a timely fashion in keeping with company guidelines.
- Respond to routine treatment/diagnostic transfers, as required, in a timely fashion in keeping with company guidelines.

- Provides assessment and treatment to ill and injured person(s), which are consistent with The Ambulance Act And Regulations, Saskatchewan Health, Emergency Treatment Protocols, College of Paramedics and organizational policies and procedures.
- Transport Patient(s) to the appropriate facilities in accordance with established policies and procedures and, with a minimum of delay.
- Provides client-focused service and patient care.
- Provides receiving medical authorities and Rosthern Ambulance with an accurately completed Saskatchewan Health Patient care Report Form (PCR) outlining observation, treatment and any changes that occurred during the call for all calls.
- Provide verbal reports to other health care providers, as required, for any patient treated or transported.
- Obtains and documents complete information for billing purposes on all PCR's
- Completes appropriate statistical Documentation.

### **Minimum Qualifications**

---

- Successful completion of a recognized Saskatchewan Advanced Care Paramedic Program with current registration within the Saskatchewan College Of Paramedics or eligibility to obtain registration.
- Current Cardio Pulmonary Resuscitation (CPR) Level "C" certification.
- International Trauma Life Support (ITLS) certification.
- Valid Saskatchewan Class 4 drivers license
- Working knowledge of the application and operation of all emergency patient care equipment currently in use by Rosthern Ambulance.
- Physically fit with the ability to lift loaded stretchers on a regular basis.
- Ability to operate emergency vehicles in a safe and effective way with a minimum of delay during emergency situations.
- International Trauma Life Support (ITLS) Instructor, CPR Instructor, and First Responder Instructor trainer are preferred.
